Mr. Martin asked Council to consider putting something around them. Caren Andrews stated Dan Wright is exploring options to remedy this issue and will be reporting back to Council soon.

FINANCE COMMITTEE REPORT

COMMITTEE AND PROFESSIONAL SERVICES REPORTS

A. Code Department

Councilor Byrne introduced the James Ebron handicapped parking denial. This topic was discussed last month. Councilor McDonald stated the wife came into her office and explained her medical issues. Councilor McDonald saw firsthand the difficulty the resident had in walking. She supports the request.

Councilor Byrne reminded everyone of the ordinance that states a resident needs a handicapped license plate in order to be considered for the handicapped parking space. This resident has a placard. Councilor McDonald will work with the resident on the plate.

Steve Travers summarized the Property Abatement Program. The bank owned properties reimburse the Borough for the abatement expenses. Councilor McDonald asked that residents be given an opportunity to compete for the business. Steve Travers explained the vendor requirements which include liability insurance, commercial grade landscaping equipment, and a trash pump.

Steve Travers invited Council to take a site visit with him to review the conditions of the blighted properties. President Kemp stated he wants to move forward with the current vendor to finish up the projects for the year.

Councilor Byrne mentioned signage on windows in Commercial Districts. Steve Travers took pictures and delivered letters to those who were not in compliance.

Steve Travers informed Council that he is in the process of coordinating a Zoning Task Force meeting.

F. Library

G. Yeadon Economic Development Corp (YEDC)

President Kemp reported the YEDC is asking for \$5,000 for startup costs. He asked the Solicitor for guidance with the Borough giving funds to a 501(c)(3). Solicitor Ewald stated under the Borough Code the municipality may appropriate funds for community development programs internally or through other agencies. Mayor Butler asked if they were creating another 501(c)(3). Solicitor Ewald stated the tax code was revised requiring more frequent filings. YCDC was inactive and did not file the IRS paperwork. Also it was noted the name of the group changed to the YEDC.

President Kemp announced progress is being made in the Finance Director search with a decision being made in the near future.

J. Flag Day

Council Stinson reported the Flag Day Committee will have their first planning meeting for Year 2012 activities on October 11, 2011.

SOLICITOR'S REPORT

Solicitor Ewald explained the municipal real estate tax lien sale program. In the past the Borough worked with XSpand. XSpand is no longer purchasing the liens due to a change in their business model. The Borough is working with a different entity called Municipal Revenue Service. They are offering ninety (90) percent of the face value for all Year 2010 delinquent properties. Council was interested.

Solicitor Ewald stated the Borough will need to adopt an ordinance and agreement to join the Eastern Delco Storwmwater Collaborative (MS-4). Eight communities were invited with four including Yeadon expressing an interest. The other communities interested are Sharon Hill, Upper Darby, and Collingdale.

NEW BUSINESS

President Kemp reminded everyone of a PECO grant received a few years back for a strategic plan for the Yeadon Community Park. He will be discussing this at the upcoming Elm Street meeting.

CITIZEN'S FORUM

Dr. Carolina Harris wants to be sure Council is following the laws when it pertains to the YEDC. She asked for an agreement of understanding with the YEDC.

Dr. Harris asked to update the Comprehensive Plan.

Dr. Harris commented on the resident that was denied handicapped parking and asked for a little more compassionate.

Dr. Harris asked when the Borough was going to work on the 2012 Budget. Caren Andrews stated the department heads have been crunching numbers. Public meetings will be announced soon.
