PRESENTATION - HANDICAPPED PARKING SPACE OPTIONS FOR BOROUGH HALL - Matt Black, Fire Marshall and Health Officer

In order to be ADA compliant, the Borough parking lot should have two handicapped parking space s per fifty parking slots. The Borough has one employee who has handicapped tags who parks in the handicapped space. If a resident with handicapped tags came to borough hall doing business hours there is no place for them to park. The Fire Marshal distributed copies of the handicapped parking ordinances, a schematic of parking lot and offered two options for handicapped parking spaces. He also suggested that a maximum time limit be established for the three parking spaces adjacent to atrium entrance. Additional discussion about moving employee parking across the street to the Yeadon Movie Theater parking lot. Councilor Kemp would like to work with the Fire Marshall on the project and reporting back to Council.

PRESENTATION - Tonia Covington Branch Manager, Franklin Mint Federal Credit Union-Mercy Fitzgerald Branch.

Ms. Covington spoke about forging a partnership with Yeadon both in the form of financial sponsorship and doing outreach to the community on financial literacy issues. They will partner with the Borough for Flag Day 2013.

PRESENTATION BY MASTER'S CANDIDATE'S UNIVERSITY OF PENNSYLVANIA- Jed Poster, Master's Candidate in City Planning

Mr. Poster gave an introduction of the work team and an overview of the assignment. The team has been working on project within Borough for the last three months. Their project was graded on a thirty minute presentation at University and the book that was created by the team. Through analysis of baseline data identifying strengths and areas of needed growth for Borough, focusing on 3 key areas.

North Church Corridor (Penn Street to Baily Road) focused on Transit Orientated Development (TOD) to facilitate a better merchant/pedestrian environment. Reconfiguration of Penn-Church intersection to make it more pedestrian friendly as it is a crucial pedestrian entrance to Regional Rail station.

South Yeadon (YSC & Yeadon Plaza Shopping Center) combining both venues in a planning unit development overlay. Proposed Skatepark, 2 outdoor tennis courts. 1000sq ft clubhouse, walking trails. If the Borough were to sell a portion of would generate \$900,000 which would fund infrastructure improvements. Site of former Acme supermarket create a global market like the Reading Terminal Market.

Housing affordability create accessories dwelling units by converting attics and garage spaces into rental units. Proposed revision to Yeadon's housing ordination to allow detached rental spaces. Open spaces recommendations: open Mt. Moriah cemetery for public use with public gardens, bike and pedestrian trials. Translate Borough website into foreign languages of residents new to Yeadon who are also new to this country to understand their rights and responsibilities.

Councilor Johnson was surprised that Council was not aware of the project and asked the students how they identified whom to interview regarding the project. They were advised by then Borough Manager that she was the contact for the project.
