# DELAWARE COUNTY, PENNSYLVANIA LEGISLATIVE COUNCIL MEETING July 20, 2017

The Borough of Yeadon Legislative Council Meeting was called to order at 7:35 PM.

# 3. CITIZENS FORUM (Comments limited to 3 minutes)

- Dr. Caroline Harris addressed Council regarding the collection of delinquent taxes. She inquired whether any Public Hearings were held in regards to this, and if it changes the way taxes are collected. Dr. Harris also addressed the construction of a Recreation Center and said it should involve a Public Hearing. The RDA has been having meetings and at the last meeting it was decided to form a Community Advisory Council. She believes that RDA is an instrument for the Borough and asks that the community engages in the Community Advisory Board.
- Liana Roadcloud requested to view all of the recordings of the Council meetings from the past 7 months, as recorded by Garry Core. She was instructed to submit a Right to Know request.

# 7. ENGINEER'S REPORT

- Engineer, Eileen Mulvena, presented an update on the bids for the demolition of 508 Orchard Ave. Two bids had been opened that morning but supporting documents for the most expensive bid are missing. Ms. Mulvena does not feel they should be considered a responsible bid. The second and lowest bid, has no proven experience demolishing buildings that do not stand alone. Their bid was \$74,500. The grant for this project is \$40,350 creating a shortfall of approximately \$35,000. The Borough would need to request permission to request additional grant funds from the County, put the project out for re-bid, or cover the difference.
