Dear Mayor Hepkins:

It is my pleasure to present to you and Council the Police Department's Monthly Report for the services performed by the members of the Yeadon Police Department for the period April 01-30, 2018.

---

**General Information.** Information is a vital part of being able to provide answers to residents that can help others understand the dynamics of law enforcement and the activities that occur daily to make a community safe. This report contains information obtained from the Department's Alert2 Information Records System, as well as personal insight related to daily operations of the Police Department. Instead of providing you with just totals, I wanted to provide you with reports that provide more information to better understand what goes on in the Borough, and the work of the personnel in the Department.

**Crime Prevention.** Through continued use of the Borough's Public Website, Nextdoor, Social Media platforms, and interaction with the public by officers, you and Council; residents have been vigilant in securing property, keeping outside lights on, reviewing video surveillance, and calling police for any and all potential suspicious activity.

**Crime ALERT.** An increase in (5) burglaries or (3) attempts have been noted. Investigators are working diligently and I can report at least 2 of the 5 reported incidents have been cleared with arrests of 2 offenders through joint work with patrol and detectives. Residents actually spotted a subject described as a Black male, 20's wearing a black jacket carrying a backpack trying a window and chased the male off. Police were called, and could not locate the subject. Patrol is working diligently to make their presence known and deter further acts, while investigators follow up on potential suspects.

**Safety Tip – Vacation Planning.** Vacation season is fast approaching and I wanted to provide some thoughts to consider to enjoy the time away from home and secure your property as best as one can.

1. Consider packing and loading your car trunk (only) with the luggage and things that can fit after it gets dark, so you're not advertising that you are going away.
2. Don't pack anything in the passenger compartment until you are getting ready to leave.
3. Do tell trusted neighbors where you are going, to secure your mail, check your property, and call 911 if they see something suspicious.
4. Make sure a neighbor has your contact information should we or someone need you in an emergency.

5. Most banks now have features on their websites that allow you to provide travel alerts, which can help you with avoiding declined transactions, as well as alert banks and you to misuse of a credit card elsewhere.
6. Leave lights on timers or a light on in different parts of the home.
7. Consider installing motion detection lights outside your home.
8. Unplug all unnecessary appliances.
9. Consider installing cameras or a home security system that can alert you and/or us to a problem. (Plus this can save on your insurance costs per year).
10. If leaving a vehicle behind, park in your driveway if possible, and LOCK IT.
11. Before driving away, make sure you have locked EVERY window and door.
12. Relax, and have fun!

*Safety tips will now be a monthly part of this report.*

**Community Clean-up.** The 70<sup>th</sup> Street corridor into the City of Philadelphia received a make-over on April 21, 2018. Comcast Cares, community members, Borough officials, Public Works, and even a Police Officer all got together and helped clean up the area. A job well done and a great example of people coming together to make Yeadon a better place to live, work, and visit.

    - i. This is a new statistic that will be part of this report. A Juvenile Petition is an arrest of a juvenile offender that results in a Criminal Record being generated. A Petition is for a felony or misdemeanor offense, which the juvenile has been charged with, and the District Attorney has reviewed and approved related charges.

**Traffic Citations issued: 80**

Based on a review of the areas that present repeated problems, complaints from the public, or officer and/or my observations, directed traffic patrols will be continued for resident, pedestrian, and motorists safety. Note that the number reflects traffic infractions that may also be charged on a criminal complaint as noted on the arrest details report. Most common infraction was speed and stop sign violations. Traffic enforcement was conducted using speed timing devices. Lines have been painted throughout the Borough. They do two things aid officers in enforcement, and become a visual deterrent to some motorists to prevent speeding.

**Non-Traffic Citations issued: 5**

The most common offense for the month was criminal mischief to property.

**Police Department Activity.**

1. The contest for the kids in our schools for a new police patch and car design has ended and the winners were presented certificates and cash gift card prizes at the April 19 Council Meeting. A positive night for our community revealing the talent and involvement of so many youth in our Borough. Runners-up received their certificates and prizes from a personal visit at school during their lunch from me.
2. Department now participates in a non-profit *Fight Crime: Invest in Kids* program.
  - a. Program involves outreach, interaction, and work with youth to offer positive influences in behavior to break the cycle of violence and crime in kids.
3. Officers continue make daily visits to the schools.
4. Active (Shooter) Killer training continues.
  - a. Evans and Cypress schools are scheduled for Active Killer training response.
  - b. Lockdown drills will now have police presence and review as they are conducted.
  - c. Work with the School District continues to bring their training and policies up to current standards for School Safety based on my training and experience.
5. Tactical entry tools are now in place, and tactical response vehicles are now in service in the Borough.
6. To reduce vehicle pursuits and crashes, Spike Strips are now part of the tactical response equipment in use for Yeadon Officers. Pursuits that may start in other jurisdictions have the potential to navigate through Yeadon endangering our residents and motorists. Yeadon Officers now have a tool to assist other jurisdictions and ourselves with ending a pursuit in a controlled manner.
7. A new program to monitor police scheduling is underway, to ensure adequate records are maintained.
8. *Racial Intelligence* training is being planned for May or early June for all officers.
  - a. This program for which I am a certified instructor teaches officers de-escalation techniques and to recognize the factors of human behavior that contribute to problems during interactions with the public. It teaches officers about themselves, and improves our ability to be empathetic, understanding, and approachable through the betterment of our social and emotional intelligence.
9. Promoting Yeadon through the use of my twitter account @ChiefChachi\_YPD continues.
10. April 21, 2108 I spoke at the Yeadon Library with a panel about Human Trafficking.
11. An invited guest, I spoke to Penn Wood high school students on April 26, 2018 about their rights, peaceful protest, and positive interactions with and why they should consider becoming a police officer, and most of all a Yeadon Police Officer. Thanks to Valencia Peterson and Jennifer Hoff for the invite and considering me for this endeavor.
12. Flag Day meetings continue, and the event is on point to be an outstanding occasion this year.
13. Attended the monthly Public Safety meeting.
14. The Police department is currently undergoing a complete clean-up and remodeling to improve morale and work performance even further.
15. A new patch is complete, and that too will be prominently displayed on our uniforms before the Flag Day celebration in June.
16. On-going interviews for part-time police officers continue.
17. Charles A Wilkins stopped in the Police Station and gave our Department a quantity of tourniquets, a vital part of the officer survival and wounded civilian kits in service. THANK YOU!
18. The new Glock 9mm handguns are arriving for service and officers are being qualified.
19. The Body Cam Program appears to be on track for initiation in Late May 2018.
20. I am working on a program I call **STOP. Stop Theft of Property**. The premise of the program is an identifying mark or sticker on personal property such as a car, bike, tools, etc.

that give an Officer the expressed authority of the owner to stop and ascertain that the property belongs to the person in possession of the property. More details to come.

**Police Training.**

1. Active Shooter training by the Chief's Association was attended by three (3) more Officers.
2. Mandatory In-Service Training continues which includes:
  - a. Firearms requalification.
  - b. First Aid.
  - c. Yearly Police required coursework (ACT180).
3. Three (3) Officers successfully completed training with the Region 1 Tactical Team as Patrol Rifle Instructors through Singleton International.
4. Officers also attended training for:
  - a. Investigations of Crimes against Children.
  - b. Standard Field Sobriety Testing Recertification.
  - c. Criminal Justice Network Tac Officers Recertification.
  - d. Three (3) Self-Treating the Wounded Officer
  - e. Standard Field Sobriety Testing Training
  - f. Standard Field Sobriety Testing and DUI Checkpoint Recertification
  - g. Spike Strip Instruction
  - h. SWAT training (Firearms, Entry Tactics, etc.)
5. Sgt. Johnson will be attending a Police Background Investigation Courses in the coming weeks due to the extensive work I have him completing for our new hires.
6. My yearly required ACT 180 police certification courses have been completed for 2018.

Training is a vital aspect of a professional police agency, and ongoing education and training will be afforded officers to promote officer development and a quality of service to the public second to none.

**Recruitment, Hiring, Promotional Examinations**

1. Seven more (7) individuals are being interviewed for Part-Time Police Officer positions.
2. Applications are streaming in, and I have been receiving a lot of feedback, that people want to come work here. I am receiving phone calls and applications at a rate of about 2 per day.
3. During the workshop at Penn Wood High School I promoted the benefits of becoming a police officer and especially a Yeadon Officer. The quality of questions, interactions with the students was incredible. The workshop was another example of the positive interactions with our youth, which I strongly support and encourage with our officers. The results can be seen in these meetings.
4. Further outreach to additional police academies and colleges to garner applicants for our department will continue.
5. I am developing a poster that I can send to academies, colleges, and other venues to seek candidates for future police officer opportunities.
6. A Career Day is scheduled for late May, and I and/or Yeadon Officers have been invited to speak and work with students that day.
