Dear Mayor Hepkins:

It is my pleasure to present to you and Council the Police Department's Monthly Report for the services performed by the members of the Yeadon Police Department for August 1-31, 2018.

General Information. Information is a vital part of being able to provide answers to residents that can help others understand the dynamics of law enforcement, activities that occur daily to make a community safe, as well as associated costs dynamic to public safety. This report contains information obtained from the Department's Alert2 Information Records System, as well as personal insight related to daily operations of the Police Department. This information can help one to better understand what goes on in the Borough, and the work of the personnel in the Department, which includes police, parking enforcement, and school crossing guards.

Crime Prevention.

- **#***MissionLockItUp* continues to generate interest and participation in the Borough. I conducted a general survey on September 01, 2018 asking for those who don't usually acknowledge the program to do so, and received 107 responses including 25 comments. I'm working on a decal that residents can get to place on their car as another reminder.
 - Failure to secure vehicles and property overnight remain one of the biggest problems within the Borough. Efforts to promote participation with #MissionLockItUp continue.
- Met with business district members to hear their concerns, and reiterate Yeadon Police's mission to be present and work towards a safe environment in the 700 Blk of Church Lane.
- National Night out was handled by Sgt. Johnson, and public safety surveys, gun locks, child ID kits, and other opportunities for residents to meet/greet their police and emergency responders were on display at Evans School on August 7.

Safety Tip – **School Violence.** I have never seen the level of violence in my career, like we all witness today. It's frightening and frustrating, yet we can make a difference together by being engaged with our kids, our community, and yes with the police. Every incident of school violence, whether it's a fight or shooting, SOMEONE knows something about it before it happens. The cycle and level of violence can be broken if we speak up and teach our kids to do the same. So tonight I ask you to be a part of the breakup of that cycle by:

- Taking the time to really talk to your kids.
- Know what they are doing online, with their social media, etc.
- Know who they are hanging out with, and where they are when you go to bed.
- Have at least one friend's phone that you can reach out to in the event there is an emergency.
- Talk to your kids about bullying, and what repercussions come from violence.
- Talk to your kids about drug and alcohol abuse, and it's better to call you or the police for help.
- Report anything that is suspicious. Our ability to stop things from happening begins with you.

Traffic Citations issued: 140

Based on a review of the areas that present repeated problems, complaints from the public, or officers and/or my observations, directed traffic patrols will be continued for resident, pedestrian, and motorists safety. Major violations continue to revolve around stop sign violations and speed.

Non-Traffic Citations issued: 12

The most common offense for the month was disorderly conduct and harassment.

Police Department Activity.

- 1. National Night Out activity occurred on Tuesday, August 7, 2018.
- 2. Football season has started and officers provide safety while PWHS Patriots play under the Friday night lights.
- 3. Sgt. Johnson attended the monthly Public Safety meeting, while I was on vacation.
- 4. Four new part-time police officers were publicly sworn in by Madam President Monroe.
- 5. The newly sworn officers are now in our 10-week field training program by a trained FTO (Field Training Officer) prior to patrol on their own.
- 6. The Body Cam Program training has been attended by all full time and all part time officers.
- 7. Identity theft and Scams is set for the Friendship Circle in September 13, 2018.
- 8. The Department continues to participate in regional DUI Roving Patrols. (OT costs for all officers involved and those working the street to supplement our involvement are reimbursed by a grant).
- 9. Youth Police Academy applications and flyers are out. The program is offered to all High School Students of the William Penn School District. Classes are scheduled to begin September 19, 2018.
- 10. A home video security camera registration program initially proposed by Sgt. Johnson is being reviewed for implementation in October.
- 11. Deer management initiatives are in development, I am frequently fielding concerns about deer in the Borough. The plan is to use police officers with archery only skills to help alleviate overpopulation.
- 12. Police Budget review and proposals were discussed at a budget meeting. Reductions in spending are being seen as a result of improved management principles and ideas.
- 13. Officers were on hand for opening day at Bell, and are back on foot patrols in schools.
- 14. Grant paid related traffic enforcement details continue in high violation incident areas.

Police Training.

- 1. Mandatory In-Service Training, as well as other training continues which includes:
 - a. Firearms and Rifle requalifications.
 - b. First Aid/CPR.
 - c. Body Cam Usage/Training completed.
 - d. Speed device re-certs.
 - e. DUI Checkpoint Re-certs.
 - f. SWAT training (Firearms, Entry Tactics, etc.)
 - g. Investigative Training for Patrol Officers (Inter-County Detective School).
 - h. Interview and Interrogation software training.
 - i. Harassment in Workplace Training.
 - j. Active Shooter/Killer training for police and Twp. Employees.
 - k. Crossing Guards received yearly instruction.
- 2. RITE Training and Domestic Violence Symposium is scheduled for September 19, 2018 for YPD and surrounding Police Departments.

Training is a vital aspect of a professional police agency, and ongoing education and training will be afforded officers to promote officer development and a quality of service to the public second to none.

Recruitment, Hiring, Promotional Examinations

- 1. Interviews for Part-Time Police Officer positions are currently on hold as I have achieved a full complement of part-time officers.
- 2. Discussions with the Public Safety Committee on promotional and police officer testing changes to the Civil Service Rules continue.
- 3. Plans for an advertising campaign for new police officers are underway with ideas being developed for flyers, posters, etc.
