Dear Mayor Hepkins:

It is my pleasure to present to you and Council the Police Department's Monthly Report for the services performed by the members of the Yeadon Police Department for November 01-30, 2018.

General Information. Information is a vital part of being able to provide answers to residents that can help others understand the dynamics of law enforcement, activities that occur daily to make a community safe, as well as associated costs dynamic to public safety. This report contains information obtained from the Department's Alert2 Information Records System, as well as personal insight related to daily operations of the Police Department. This information can help one to better understand what goes on in the Borough, and the work of the personnel in the Department, which includes police, parking enforcement, clerical staff, and school crossing guards.

Crime Prevention.

- <u>#MissionLockItUp</u> continues to generate interest and participation in the Borough and nearby jurisdictions. Weatherproof reflective stickers are available to the public and are part of the new resident welcome packets.
- Plainclothes investigations/patrols are occurring in the Borough.
- I wanted to bring to your attention an outstanding example of the proactive patrols in the Borough.
 - Recently a subject was stopped due to traffic violation, and because Ofc. Tokonitz just didn't look at the stop as a traffic infraction, a large amount of cash over \$11000, plus a quantity of drugs was seized. The suspected dealer is now in custody awaiting trial.

Safety Tip: Holiday season theft deterrence. Thieves can't wait for the Holiday season to begin, especially when everyone nowadays is shopping online and having packages delivered. With that in mind, consider these tips to avoid theft of those items you are anxiously waiting for!

- 1. The ability to track packages is easier today, so use that feature if available to track and know when your packages are coming so you can be home when they arrive.
- 2. Have a trusted neighbor take the packages in until you get home.
- 3. Consider a larger key locked mail box if you get a lot of packages.
- 4. Consider picking up your packages in person at the Post Office or local delivery location if they offer that service.
- 5. Install a security system that will enable you to see the delivery, and while this may not deter all thefts, it may also capture the thief and help aid in the investigation should a theft occur.
- 6. Don't place empty boxes of expensive items out in plain view after you open them. You're advertising to thieves what you just got.
- 7. Are you living next door to a vacant home for sale or rent? Keep an eye out for deliveries to these types of residences, because thieves and/or drug dealers will use vacant home addresses as delivery points for stolen goods or drugs and then have someone retrieve the items after delivery. CALL US!

8. When shopping place ALL items in your truck out of view, unless you are going straight home, with no stops. Don't allow a thief to help themselves to your stuff as they window shop at the WAWA you just stopped at after shopping all day. They will take it.

 - i. A Juvenile Petition is an arrest of a juvenile offender that results in a Criminal Record being generated. A Petition is for a felony or misdemeanor offense, which the juvenile has been charged with, and the District Attorney has reviewed and approved related charges.

Traffic Citations issued: 98

Based on a review of the areas that present repeated problems, complaints from the public, or officers and/or my observations, directed traffic patrols will be continued for resident, pedestrian, and motorists safety. Major violations continue to revolve around stop sign violations and speed, especially school zones.

Non-Traffic Citations issued: 11

The most common offense for the month was disorderly conduct and public intoxication.

Police Department Activity.

- 1. Yeadon Police participated in a charity drive spearheaded by Ofc. Barr to donate to CHOP for the kids. Don't adjust your glasses but most of the officers didn't shave for 'No Shave November' to collect money amongst ourselves for the donation.
- 2. Officers attended Delco DA Domestic Violence Conference.
- 3. The Department continues to participate in regional DUI Roving Patrols. (OT costs for all officers involved and those working the street to supplement our involvement are reimbursed by a grant).
 - a. Yeadon is up next for an actual DUI Checkpoint. This is paid for by a grant.
- 4. The Youth Police Academy ended with eight of the (9) students receiving their certificates at the November 21, 2018 rescheduled Council Meeting.
 - a. Thank you to Dr. Karen Hudson, Mary Nixon, Folcroft (K9) and Darby Police (SWAT Vehicles), and to all of the Yeadon Officers who helped weekly in some way to support the program achieve the success it did.
- 5. The Adult Citizens Police Academy is being prepared for late February 2019 get ready.
- 6. Deer management initiatives continue, several residents have joined the program, and others are still filtering in.
 - a. There have been no issues. THANK YOU to the residents for their participation.
 - **b.** Both the PA Game Commission Officers assigned to this area, and the Philadelphia Parks Commission supports this program.

- **c.** Officers have caught three illegal hunters in the woods during regular patrols, not while hunting!
- **d.** Deer count is at 2 Bucks, 11 does, and 2 does that succumbed to vehicle collisions.
 - i. Each doe potentially could birth two deer, so essentially 20 potential fawns have been prevented from increasing the population.
- 7. Officers continue patrols of the schools.
- 8. Grant paid related traffic enforcement details continue in high violation incident areas.
- 9. Two new cars with the new design are in service. Yeadon stands out from the rest now.
 - **a.** Paint, body work, and most graphics work are being paid through funds received as a result of sold cars owned by the Borough.
 - **b.** I'd like to say thank you to Steve D'Antonio of Body Craft Auto Body for the outstanding work, and doing more work than expected. Steve repaired some damages for no cost.
 - **c.** Thank you to Jean and her crew at 95 Signs did an outstanding job bringing my design to life.
- 10. Yeadon Police Chaplaincy Program had a nice turnout for our open house to get this program working. Thank you to Bishop Dr. Karen Dixson for taking care of this program as I was out of town on Tuesday, November 13, 2018 during this event.
- 11. A two-day Chaplaincy instruction program is being developed for the soon-to-be Yeadon Chaplains.

Police Training.

- 1. Mandatory In-Service Training, as well as other training continues which includes:
 - a. Mandatory In-Service Training required to maintain status as a Police Officer.
 - b. Firearms and Rifle requalifications.
 - c. First Aid/CPR.
 - d. DUI Checkpoint Re-certs.
 - e. SWAT training (Firearms, Entry Tactics, etc.)

Training is a vital aspect of a professional police agency, and ongoing education and training will be afforded officers to promote officer development and a quality of service to the public second to none.

Recruitment, Hiring, Promotional Examinations

- 1. Interviews for Part-Time Police Officer positions are currently are in progress again.
 - a. I lost Ofc. Salmond to the Philadelphia Sheriff's Office.
- 2. Discussions with the Public Safety Committee on promotional and police officer testing changes to the Civil Service Rules continue.
- 3. Meetings with the Civil Service Commission are in the works.
