Dear Mayor Hepkins:

It is my pleasure to present to you and Council the Police Department's Monthly Report for the services performed by the members of the Yeadon Police Department for December 01-31, 2018.

THANK YOU. As I write this report it marks my one year since being sworn on January 2, 2018. I officially began my tour on Monday, January 8, 2018 and since that time I cannot begin to thank you Mayor and Council for your unwavering support as I steered the department into a new direction. I am honored and humbled by the love and support from this community towards me, and thank you does not seem to really express my sincere gratitude to all. I would be remiss if I also did not express my appreciation and thanks to the men and women of the Yeadon Police Department who have embraced the new direction we have started on, and work tirelessly to bring a positive change to policing to in Yeadon. I look forward to an amazing 2019, and new endeavors that continue to make Yeadon shine.

General Information. Information is a vital part of being able to provide answers to residents that can help others understand the dynamics of law enforcement, activities that occur daily to make a community safe, as well as associated costs dynamic to public safety. This report contains information obtained from the Department's Information Records System, as well as personal insight related to daily operations of the Police Department. This information can help one to better understand what goes on in the Borough, and the work of the personnel in the Department, which includes police, parking enforcement, clerical staff, and school crossing guards.

#### Crime Prevention.

- #MissionLockItUp continues to generate interest and participation in the Borough and nearby jurisdictions.
  - Fox 29 did a feature story on the program which has received great positive feedback, and spotlighted Yeadon in the news.
- Plainclothes patrols are occurring in the Borough.
- Safety tips and public interaction continues with Nextdoor.

Safety Tip: It's cold outside right. Want to get into a warm car right? Just going to start it and come back in a few minutes after its toasty inside, right? WRONG. You're inviting a thief to take your car. Most stolen cars nowadays are a result of this scenario playing out. Did you think that it might not just be the person walking down the street who sees the opportunity, but a car with multiple occupants on a morning drive through the area looking for the telltale signs of steam/smoke coming from the cold engine exhaust? You come out your car is gone. The same thing for a stop at WAWA, or any other store, turn your car off, take the keys, and keep the car yourself, don't give a thief an opportunity to just easily take it. Think smart! BE SAFE!

    - i. A Juvenile Petition is an arrest of a juvenile offender that results in a Criminal Record being generated. A Petition is for a felony or misdemeanor offense, which the juvenile has been charged with, and the District Attorney has reviewed and approved related charges.

#### **Traffic Citations issued: 26**

Based on a review of the areas that present repeated problems, complaints from the public, or officers and/or my observations, directed traffic patrols will be continued for resident, pedestrian, and motorists safety. Major violations continue to revolve around stop sign violations and speed, especially school zones.

#### **Non-Traffic Citations issued: 11**

The most common offense for the month was disorderly conduct.

### Police Department Activity.

- 1. The Department continues to participate in regional DUI Roving Patrols. (OT costs for all officers involved and those working the street to supplement our involvement are reimbursed by a grant).
  - a. Yeadon is up next for an actual DUI Checkpoint. This is paid for by a grant.
- 2. The Adult Citizens Police Academy is being prepared for late February 2019.
- 3. Deer management initiatives continue, several residents have joined the program, and others are still filtering in.
  - a. There have been no issues. THANK YOU to the residents for their participation.
  - **b.** Deer count is at 2 Bucks, 20 does, and 2 does that succumbed to vehicle collisions.
    - i. Each doe potentially could birth two deer, so essentially 20 potential fawns have been prevented from increasing the population.
    - ii. Program has been extended to the end of the season until Jan 26, 2019.
    - iii. Venison has been distributed to local families and St Lewis Church.
- 4. Officers continue patrols of the schools.
- 5. Officers played Christmas music over their loudspeakers during patrols on Christmas Eve.
- 6. Grant paid related traffic enforcement details continue in high violation incident areas.
- 7. Yeadon Police Chaplaincy Program training planned for February prior to Citizens Police Academy.
- 8. Officer Austin Gallagher purchased nets for Bell School basketball courts, and Officer George Millison helped him put them up. The tweet I posted gained attention from Fox 29 who did a feature story on Ofc. Gallagher putting Yeadon in the spotlight positively again!
- 9. Thank you to everyone who brought food and goodies to the Department during the holidays!

### Police Training.

- 1. Mandatory In-Service Training, as well as other training continues which includes:
  - a. Mandatory In-Service Training required to maintain status as a Police Officer.
  - b. Firearms and Rifle requalifications.
  - c. First Aid/CPR.
  - d. DUI Checkpoint Re-certs.
  - e. SWAT training (Firearms, Entry Tactics, etc.)

Training is a vital aspect of a professional police agency, and ongoing education and training will be afforded officers to promote officer development and a quality of service to the public second to none.

### Recruitment, Hiring, Promotional Examinations

- 1. Interviews for Part-Time Police Officer positions are currently are in progress again.
- 2. Interviews for crossing guards are being conducted.
- 3. Discussions with the Public Safety Committee on promotional and police officer testing changes to the Civil Service Rules continue.
