In support of the YEAA basketball league having evening games, Council wants to make sure they are able to utilize the grant allotted to them.

Questions:

Councilor Johnson: Will the residents in that area be notified that the lights will be left on longer? Will the lights be on a timer? What is the process with the lighting?

President Monroe: All information will be outlined in the bid. However, the lights are not on the perimeter of the streets, these lights will be projected onto the basketball court. The lights will not be directed to any specific homes.

Councilor Cave: Now that residents will be at the park later, will the parking lot be lit?

Monroe: There are street lights. Even without the appropriate lighting, last year people were at the basketball courts late night. Also, there is LED lighting that will add additional lighting.

Additional Business:

- Johnson Controls, who did the LED Project, noticed there was a separate port that had additional lights that needed new recommendations; Library, Borough Hall, Yeadon Avenue, and another street. Approximately 15 additional lights are recommended. Conversations were made with the company about proceeding, which would be an additional \$17,000.
- The Engineer is preparing specs for the cameras. She has received all contracts and other requested information from management. The Engineer is currently awaiting bids from the contractors so she can ask Council for authorization.
- Business owner/resident, Charles Pavia, contacted the Borough with the intent of beautifying the 700 block of the Church Lane Business District by suggesting hanging planters along the light post. Plans are set to pick up the planters no later than Tuesday, June 18, 2019. Installation will follow.
- It was suggested that a financial consultant be contracted to support the Tax Collector with her assignments. This is a professional service.
