#### 3. CITIZENS FORUM (comments limited to 3 minutes)

• Richard Smalley (Yeadon Parking Enforcement Officer) – 21 N. Rigby Avenue Lansdowne, Pa 19050 – Mr. Smalley is concerned about Graceland Cemetery, the resting place of over 1600 Civil War Veterans and civilians. He is appalled that residents walk their dogs through the cemetery and allow the dogs to desecrate the graves. He recommends that Council put a fence around the cemetery in order to prevent dog walking. Also, the current fence is in bad condition.

A lot of the houses in Yeadon do not have house numbers which can be a dangerous situation, especially if emergency personnel cannot locate the home.

There are lot of unpaid parking tickets in Yeadon and Mr. Smalley recommends having a boot program for cars if a certain amount of parking tickets do not get paid. He mentioned that there is a resident that has 23 unpaid parking tickets, another with 20 unpaid tickets, etc. He would like Council to recommend initiating a boot program for cars in the area that do not pay parking tickets.

Mr. Smalley congratulated Council on doing a good job.

- The Borough is currently in litigation with the Archdiocese of Philadelphia and the cemetery. We are in the process of handling a discovery. The argument the Borough and the school district are making is that the Archdiocese sold the cemetery and took a ninety-nine-year lease back. The Archdiocese's position is that they still own the cemetery, which is legal fiction. If the Borough wins, the cemetery will be added back to the tax.

Discussion: was had regarding the surveillance camera project by Council, Chief Paparo, and the Finance Director, Nafis Nichols – Issues were raised regarding types, pricing, and location. The surveillance camera project proposal came in through COSTARS at \$71,252. There is a grant in the amount of \$50,000 that must be spent by 12/31/19 and the Borough would be responsible for the remaining amount of \$21,252.

Brief Discussion: The engineer raised issues regarding prevailing wages and an inspection being done by an electrical underwriter, which protects the Borough, putting all the liability on the vendor. The motion was then amended to include the engineer's recommendations.

Brief Discussion: The Solicitor said that the Redwood Sanitary project is currently under contract with JMC, the contract is on hold in part because we are trying to obtain necessary clearances from PECO. In the event of JMC canceling the contract Council is being asked to authorize the acceptance or advertising the rebid. We are continuing to negotiate a change order with the current contractor. As a result, the Solicitor asked Council to reject any and all bids received on a contingent basis, and noted that we did not receive any bids. The Solicitor concluded by requesting consideration of a motion to authorize the work to be done on 728 Yeadon and 1108 Yeadon Avenue to stabilize them, he thought the engineer could explain exactly what that means.

\*Note: The Solicitor stated 1108, but it is actually 1011.

The engineer explained that 1011 Yeadon Avenue requires a tarp being placed over it, and nominal work needs to be done. We can have a contractor do the work, and lien the property to prevent the water from going into the roof line of the next house.

The engineer further explained that 728 Yeadon Avenue involves the demolition of the rear garage, and 726 Yeadon Avenue wants their garage demolished as well. She has a contractor lined up to complete the work as an emergency. The structural engineer thought if we waited much longer we would have a disaster, so she asked if we could wait until the upset sale on 9/12/19, no one purchased the property at the sale so the structural engineer is likely to say the demolition should be done. The Borough would pay for 726 Yeadon Avenue because it was

damaged by 728 and demolishing both is less expensive; otherwise the Borough would pay to stabilize 726 Yeadon Avenue's garage.

• Motion to demolish the garages at 726 and 728 Yeadon Avenue, remove the front porch of 728 Yeadon Avenue, and to stabilize 728 and 1011 Yeadon Avenue to make them safe.

- Brief Discussion: On September 17, 2019, the Borough hosted a viewing of the nationally shown video "Walking While Black: L.O.V.E. is the Answer," which focused on how residents and police can learn from each other and start a dialogue of healing and understanding in order to create a better relationship with each other. The Mayor, Council President, and Chief Paparo briefly discussed some of the highlights from this showing. L.O.V.E. means Learn, Open Your Heart, Volunteer, and Empower Others. The video can be rented on Amazon. The Chief will set up another showing in January or February and include high school students.

Yeadon had the largest audience. We were one of 12 involved, which included colleges. President Monroe expressed how proud she was of the Mayor, the Chief, the team, and the community members that came out to start the conversation and that she feels blessed to live in a community where these types of issues do not exist because we're proactive and we're still a small community led by a great Mayor and a great Chief and she hopes we can continue. Job well done.

The Mayor added that a Bucks County couple attended this meeting, because their police chief would not allow this in their county, so they came here to take part with us, which is a feather in our cap. He and the Chief work well together and when the Chief brought it to him he thought it was a great idea, but he did not realize how great. Fox 29 News', Joyce Evans, came and ran a story on the matter. The meeting was well attended with approximately 65 residents.
