MAYOR'S REPORT

Requested that the Mayor's Report be accepted as submitted at Caucus.

6. PRESIDENT'S REPORT

• The Mayor and Council President Monroe presented a service award to Sharon Council-Harris for her years of service as a Councilor.

7. MANAGER'S REPORT

- The installation process for the sound system on the second floor Hall began today and should be completed in a few days.
- Management recommends the Borough holiday schedule for the floater holidays, which are Good Friday and Columbus Day, be eliminated and instead be a scheduled paid holiday. Management further recommended that Flag Day and Christmas Eve be approved as paid holidays.

8. SOLICITOR'S REPORT

The Solicitor and Finance Director gave brief remarks regarding the tax bill. The Tax Collector, Julianne James, provided more detail. She stated that realtors and organizations are charged a \$5 when requesting duplicate tax bills. However, residents are not charged for these services. She recommended the fee to receive a duplicate tax bill be raised to \$10. She further stated that when realtors and organizations request a certificate/proof of payment of taxes, there is a \$15 fee and once paid they receive both the municipal and school tax. The Tax Collector recommended that the fee be changed to \$10 each for the municipal and school certificate.

• Motion to charge a \$10 fee for a duplicate tax bill and charge \$10 each for the local municipal tax certification and the school tax certification for realtors and organizations.

• The Solicitor stated that last month Council discussed in an Executive Session issues related to an employee with the initials R.I. who sustained physical injuries

to his body while performing Borough duties. He said the discussion involved the potential of having a settlement with the employee and allowing him to collect fifty percent of his salary through the pension fund due to his current service-connected disability. He further stated that his medical records were reviewed by a doctor and the Borough Solicitor, there was concurrence that he is permanently disabled, as such the Solicitor asked that Resolution #2019-007 be adopted.

• There was a brief discussion with Council and the Borough Manager regarding the holiday schedule. It was decided that the recognized schedule would include all previously recognized holidays; in addition to, the floating holidays of Good Friday and Columbus Day becoming paid holidays as well as Christmas Eve.

• The Solicitor stated there has been a series of real estate tax appeals that have taken place within the Borough and there are a number that the school district has taken up. Given that the reassessment is happening people are trying to get their property values as low as possible. He received notification that one property went from \$160,000 to \$46,000 on appeal. He mentioned that the school district has challenged it, so he asked for authorization to file the appeals. He will bring the appeals to Council and Council will decide whether to proceed with them because he does not want to lose the appeal time frame.

Council Cave asked if it was more prudent to just give the authorization to appeal it when the Solicitor receives it. The Solicitor said yes, but he would still come to Council because it is litigation.

The Solicitor added that he and the school district are working closely together and discussed possible reasons for the changes.

Motion to authorize the Solicitor to join the appropriate assessment appeals that the school district is a part of currently and to challenge the assessment appeals that we deem to be too low.

9. TAX COLLECTOR'S REPORT

• Borough Revenue received: \$3,125.54 from sewer; \$1,732.50 from refuse; for a grand total of \$10,134.03.

ENGINEER'S REPORT

• NDI recommended rejecting the bid received from Alpha Omega Construction Group for the Borough Hall roof repairs and authorization to rebid the project because there was only one bidder and the bid for \$89,000 is much higher than the \$20,000 estimate that we have received from Martin Burke Roofing Consultant.

The Solicitor requested this motion be tabled for the next meeting on Monday, January 6, 2020. At the Reorganization meeting Council can consider any and all business that comes forth. Given that the Council expires on the 1st Monday this Council cannot authorize a bid for the next Council.

• NDI recommends authorizing the Engineer to prepare and re-advertise for bids for the replacement of the Library HVAC system.

The Solicitor requested the motion to prepare the bids and on January 6th Council can authorize the bids for advertisement.

• Motion to adopt Resolution #2019-006, designating the Community Development Block Grant (CDBG) priority and alternative projects to be applied for in the 2020 CDBG.

• Stormwater Tip: More Salt does not equal more melting snow. Follow the product instructions when spreading de-icing material and give it time to work. Clean up any material remaining after the snow/ice melts.

Councilor Johnson nominated Charles Wilkins.

The Council President clarified that the current Borough Council member position was open for nominations via email and was advertised on the website since the last meeting through December 30th.

Brief Discussion: Council and the Solicitor discussed whether a Council member can apply for a vacant Council position while still being a member of Council. The Solicitor stated that nominations can only happen on the floor of Council. He also stated that there is no resign-to run provision in the PA Borough Code or Yeadon Borough Code. He further stated that at the time the nomination was received for Councilor Cave, he was no longer a member of Council and there was no waiting period, no law, or any case law that governs this particular issue. He referenced §901, 902 and 903 of the Borough Code and mentioned that the Borough must fill the vacancy within 30 days.
