Yeadon Police Monthly Report: May 2020

### Mayor Hepkins:

It is my pleasure to present to you and Council the Police Department's Monthly Report for the services performed by the members of the Yeadon Police Department for the month of May 2020.

### **COVID19 Ops and Issues:**

- Police operations continue despite the pandemic, with no infections noted within the PD or staff.
- Use of Nextdoor, Twitter, Facebook to help alleviate anxiety and promote involvement with the community to answer concerns for food assistance, mental health assistance, medical, and general community concerns is well established and working well, in addition to the information supplied by the Borough on the Borough website.
- The School District the school year for pay related to seasonal staff would end on May 1, 2020.
- Police staffing for civilians resumed on May 4, 2020.
- Delaware County is in the yellow phase and no issues to report as move back into work, etc.

### Homicide of George Floyd and Protests

I have attached my response to this horrific incident in Minneapolis that resulted in a murder at the hands of police. As a result of peaceful and violent protests, Yeadon Police officers have been extremely busy in an effort to create a visible presence to ensure the safety and welfare of our residents, visitors, and businesses that thrive in this community. Additionally, I have been busy in writing policy and ensuring our officers maintain the highest level of professionalism and integrity in these trying times. I have also attached a new Duty to Intervene and Act Policy which other police agencies in Delaware County have reached out to me to obtain for their use. I have been asked to participate and have done so on a national Zoom call sponsored by the Walking While Black movie creator AJ Ali, to discuss this senseless homicide and police reform. I have also been consulted by Bucks County on the topic, and have been asked to be part of the new Delaware County Police Reform Task Force.

### Police Department Activity.

- 1. General Orders related to police operations continue as needed pursuant to operational needs.
- 2. All Activities related to COVID business closure compliance checks, research, DECON activities, purchases, any activity whatsoever related to responding to the pandemic continue to be documented and forwarded to the Emergency Management Director Rufus Stokes, and the Borough Manager's Office for FEMA and PEMA requests for documentation for potential recovery of expenditures related to the pandemic response.
- 3. All community activities that involved use of the Borough facilities or meeting in person continues to be on hold. (Citizen's Academy, LOVE Garden).
- 4. Residents, businesses, and groups continue to bless the Department with PPE and food donations.
- 5. Businesses are monitored for compliance with State Orders governing businesses allowed open.
- 6. Reports being completed for potential reimbursement for COVID19 related expenses and expenses related to Emergency Declaration due to violent protests and riots in the area and police responses to ensure public safety and equipment purchases.
- 7. Police assisted with and participated in 2 peaceful protests in Yeadon on June 7 and June 14.

#### Police Training.

- 1. Officers are being kept up to date with all means to protect themselves as best as we can from an unknown virus amongst us.
- 2. Mandatory In-Service Training for 2020 is confined to use of a computer.
- 3. All other training is on hold.

Chief Anthony "Chachi" Paparo, The murder of George Floyd

My thoughts and prayers are with the Floyd family, and while I have commented on my Twitter account, I wanted to reach out to you here so you would have no doubt where I stand on this senseless act in which a life was taken that was nothing but homicide. The day I watched the video, I literally got sick at what I saw. Yeadon Mayor Hepkins happened to call me right after I saw it and could tell from my voice, I was troubled. He asked if I was good, and I replied no I'm not, I'm literally sick to my stomach and described the video for him. We talked. I made the comment that we cannot begin to succeed at policing until we (police) police ourselves. I immediately sent this video out to all members of the Yeadon Police Department, and it was discussed at length with the officers, and I can tell you they were sickened by the video as much as I was.

I want to tell you that I would not need an attorney to tell me what I saw was a murder with malice, and an arrest would have been made that same day. I have been a police officer for 35 years, and there are no training or tactics I have ever had that say its ok to inflict force on the neck or other areas of the body that could result in death unless it is a deadly force situation and you are fighting for your life or trying to save someone else's life. THIS WAS NOT A DEADLY FORCE SITUATION. This was beyond wrong. This was a homicide. This was murder. Four days to an arrest was wrong, and I'm sorry everyone had to wait, and hope it wasn't going to be ignored.

The officers who watched and failed to intervene, who failed to render aid, who continued to apply pressure to any part of his body as he went limp, and the officer who could see all of this, and ignored George's pleas and those of witnesses to help him, are all culpable. They failed as cops, failed at just being human. It's not about being weak on the street. Strength, real strength and courage sometimes comes with stopping an officer who has lost sight of what they have taken their oath for.

Since my arrival here in Yeadon, I have instituted Racial Intelligence and Diversity Training, De-Escalation Training, have trained officers as negotiators, have instituted less lethal training and devices for patrol, and have written an Unbiased Policing Policy. I am also writing a new policy "Failure to Intervene" policy and directive, so there is no question about the thought process of your officers in this Department. We have a Citizens Police Academy, Youth Police Academy, Chaplain Program, a Police/Community Garden planned, and a greater connection to our youth in the schools, and so many other community policing programs to connect us together because we can't succeed without your support. Yeadon Police have also teamed with the LOVE is the Answer, Walking While Black Organization, in which we now have other police departments in PA asking us for guidance. We were the only police agency in PA that joined this endeavor that I am aware of, of which I am proud, because we are not afraid to be different and prove it.

I instill in this department that every person is a human being and deserves respect. I am not soft on crime, and some may not like my tenacity, but I will not abuse or allow officers to abuse citizens because that citizen may have committed a crime. The officers get that. They have

embraced that philosophy, and really care about this community. Will we make mistakes, yes, including myself, because we are human. BUT your officers, Yeadon's Officers, are not afraid to step in and stop an officer who may be doing something wrong or report it. They get that it's not about being weak, they get it's about doing the right thing. I am proud of them all for seeing that policing to me is more than just arresting people.

If you haven't really seen what we do here I ask you to please take a look at what we are doing that is truly different. Take a ride-along with me or any officer. See for yourself the dedication and purpose we have to serve and protect this community. We do a lot more than you think, and we hear you, we see you.

I wish there was a real way for me to say I understand your pain, but I can't really ever understand that pain because I am not black. I want to, believe me I do, but that doesn't do it justice to say that. I feel it, I see it, but I am not sure I am really finding the right words there as well, or if there are even any real words to grasp that thought. Know we, good cops think about it, we don't ignore it.

I will tell you incidents like what happened in Minneapolis pain me too, they pain good cops, because that can't be the narrative in which we live, that can't be the narrative in which any person, regardless of color can ever believe that that is a true reflection of every police officer. Yeadon Police are not that reflection, I promise you we are truly something different. We and good cops are profoundly different. We do care.

I pray that God keeps us all safe, and real change happens.

Topic: Duty to Intervene and Act Policy

Policy: #2.300 Authorized: Chief Anthony Paparo

Review: As amended or rescinded. Effective Date: June 4, 2020

#### I. PURPOSE

The purpose of this policy is to stress the Yeadon Police Department's commitment to protection of all persons regardless of race, creed, color, ethnicity, national origin, religion, sex, sexual orientation, gender expression, age, height, weight, physical or mental ability, veteran status, military obligations, and/or marital status. Yeadon Police recognize the moral and legal obligation endowed upon them concerning the welfare of an individual's life and liberty, that not only requires, but demands that an officer(s) take action to prevent or stop any member of the Department or another Law Enforcement Agency Officer from conducting, completing, or continuing any act that violates law, policy, is unethical, or fails to act such as render aid (medical or otherwise) which may harm another person or property.

This policy shall be known as the Duty to Intervene and Act Policy. This duty embodies the Yeadon Police Department Mission Statement, Yeadon Police Officer Oath, and the Law Enforcement Officer's Code of Ethics and Laws. Intervention by an officer may be verbal and/or physical, but should accomplish the objective of defusing, preventing, or stopping any act that jeopardizes the welfare of a subject or protection of property. Failure to Intervene may subject a member to disciplinary action.

#### II. **DEFINITIONS**

**Intervene** / **Act:** To come between an officer and another party, whether verbally or physically to prevent, alter, or stop the course of events in which another party may be subject to unethical or illegal conduct and/or behavior, which could escalate to injury, death, or otherwise; that is as a result of an unlawful act or a failure to perform a lawful act (i.e.: medical care) during the course of duty or while off-duty acting in the capacity of a police officer.

#### III. POLICY

Persons having contact with members of this agency shall be treated in a fair, impartial, equitable, and objective manner, in accordance with the law and human decency, without consideration of their individual demographics as defined in this policy. Yeadon Police Officers have a clear understanding of the expectations pertaining to their conduct and activities while on and off-duty. Yeadon Police Officers will come between an officer and another party, whether verbally or physically to prevent, alter, or stop the course of events in which another party may be subject to unethical or illegal conduct or behavior, especially if that conduct could escalate to injury, death, or otherwise, that is as a result of an unlawful or unethical act or a failure to perform a lawful act (i.e.: medical care) during the course of

their duty or while off-duty acting in the capacity of a police officer. Failure to Intervene and Act may result in Disciplinary Action that could result in termination.

The Yeadon Police Department is also committed to protecting its members who act on their Duty to Intervene and Act to prevent and/or minimize misconduct by another Yeadon Officer or even another Law Enforcement Agency Officer that may be involved during an incident, whether in Yeadon or outside of Yeadon during a mutual aid engagement incident.

This Yeadon Police Department Policy shall recognize the Pennsylvania Whistleblower Law, and afford officers who intervene and/or report misconduct with the protections provided under that law without fear of retribution or defamation.

Yeadon Police Officers understand that intervention in preventing and/or stopping; criminal actions, misconduct, or unethical behavior preserves their honor, integrity, and career, while benefiting all Yeadon Officers, the Community in which they serve, and ultimately may save a life. The results of misconduct or as a result of a Failure to Intervene and Act to prevent misconduct by other Officers cannot and will not be tolerated or ignored.

#### IV. PROCEDURES

### A. Intervention / Act Required

- 1. Officers observing behavior that suggests that another officer is committing or is about to commit an act that is unethical, illegal, or inappropriate shall intervene.
- 2. Evaluate the circumstances, and determine the appropriate response (verbal or physical), including removing the officer from the scene, and taking control of the incident.
- 3. A Supervisor is to respond to the scene, unless you are the Supervisor intervening at the scene.
- 4. If a Supervisor is the officer involved, Officers *will* still intervene, and notify as soon as practical another Supervisor of a higher Rank to alert them of the incident.
- 5. If the Chief of Police is the officer involved, the Supervisor will notify the Mayor of the incident promptly.
- 6. Orders or requests during an incident from a Supervisor or another officer in charge that are genuinely illegal or unethical are not valid Orders, and failure to follow such Orders show integrity, and discipline is not warranted.
  - a. However, Officers cannot defy *valid lawful* Orders in that they cannot interpret Orders the way they want or believe, there must be clear evidence that the Order issued was *illegal or unethical* for no disciplinary actions to be warranted.
- 7. Medical attention if needed or appears to be needed will be afforded without delay or hindrance, to include first aid by responding officers while waiting for advanced medical care providers to arrive.
- 8. Officers will understand the dynamics of Positional Asphyxia, Excited Delirium, and potential drug abuse physical changes to the body that can result in death.
- 9. Officers will understand the dynamics of mental health issues that could cause medical emergencies.
- 10. Subjects taken into custody will not be transported in a vehicle on their stomach.

- 11. Subjects taken into custody will not be secured on the ground in a prone position beyond the time it takes to bring them under control. Once they are under control, they will be secured in a vehicle, unless circumstances prevent such movement of the suspect. (I.E. Active Shooter incidents).
- 12. Appropriate Use of Force will be used to bring a subject under control.
  - a. That force will be subject to the circumstances involved in the incident.
- 13. Officers will employ de-escalation techniques when possible to both the officer and subject when warranted.
- 14. Body Cam video of any encounter that rises to a level of a violation of this policy will be preserved, and a Supervisor will be notified to preserve it, and such preservation will be documented.
- 15. Actions that result in a violation of this policy will warrant a full internal investigation, and appropriate authorities will be contacted for assistance and involvement when the investigation warrants such assistance.
- 16. Clear cases of criminal conduct based on Probable Cause will result in charges filed without delay.
- 17. Any officer(s) subject to arrest will be afforded all Due Process Rights, including the Right to an Attorney.

#### V. SUPERVISORS

### A. Actions and Reporting

- 1. Supervisors will respond to all reports or notifications of an incident involving this policy, and/or;
- 2. Will upon being informed or having knowledge of an incident will immediately contact the Chief of Police and conduct a preliminary investigation into the matter to gather facts for:
  - a. Incident Details.
  - b. Body Cam Footage.
  - c. Separate Officer(s) involved, and/or present.
  - d. Reason for Intervention.
  - e. What Officer(s) intervened?
  - f. What was the outcome of the intervention?
- 3. What misconduct, unethical behavior, policy violation, or potential criminal conduct occurred that lead to an Officer Intervening?
- 4. The Chief of Police will notify appropriate Elected Officials depending on the circumstances.
- 5. Prepare a report as soon as practical for the Chief of Police and/or Mayor if the Chief is the officer involved.

#### VI. CHIEF OF POLICE

### A. Actions and Reporting.

- 1. Ensure all reports of a Duty to Intervene and Act are reviewed.
- 2. Ensure investigations into the incidents are thoroughly investigated and complete.
- 3. Recognize Officers positively who have intervened.
- 4. Maintain statistics for Use of Force incidents, Duty to Intervene and Act incidents, and Police Complaints.

- 5. Approve/Disapprove any findings to determine appropriate consequences such as any disciplinary action, training issues, policy or procedure issues, or other concerns that raise questions regarding tactics, training, hiring practices, changes in law, equipment needs, or community outreach issues.
- 6. Address those concerns and needs with appropriate action.
- 7. If Probable Cause for arrest is present based on the circumstances of the incident, an arrest or warrant for arrest will be completed without delay.
- 8. Ensure any officer facing criminal charges is afforded all Due Process Rights, including access to an attorney.
- 9. Ensure intervening officers are afforded all protections under the Whistleblower Laws.
- 10. Inform the Mayor of incidents resulting from the act of an Officer intervening during the performance of their duty regardless of outcome.
- 11. Address the public and media when appropriate with clear and unequivocal information to diffuse any mistrust or creation of rumors.
