Yeadon Police Monthly Report: June 2020

July 9, 2020

Mayor Hepkins:

It is my pleasure to present to you and Council the Police Department's Monthly Report for the services performed by the members of the Yeadon Police Department for the month of June 2020.

COVID19 Ops and Issues:

- Police operations continue despite the pandemic, with no infections noted within the PD or staff.
- Use of Nextdoor, Twitter, Facebook to help alleviate anxiety and promote involvement with the community to answer concerns for food assistance, mental health assistance, medical, and general community concerns is well established and working well, in addition to the information supplied by the Borough on the Borough website.
- Delaware County is in the green phase and no issues to report.

Police Department Activity related to the aftermath of the homicide of George Floyd.

- 1. Protests held on June 7 and June 14, with no issues related to the peaceful activity.
- 2. Protest held at the Nile Swim Club for Juneteenth, with no issues related to the peaceful activity.
- 3. Participated as a panelist for several local communities including Bucks and Chester Counties, activist, youth, and college professor related requests.
- 4. Participated in National Forum for Police Reform.
- 5. Policy revisions being done for Use of Force, Exculpatory Evidence Policy, and entire Yeadon Police Manual.
- 6. New Use of Force Forms being completed and will be presented to Mayor and Council within the week.
- 7. New Complaint and Use of Force Database to be completed prior to end of July 2020.
- 8. Plans for 2nd Annual National Day of Reconciliation is underway for September 17, 2020.
 - a. Mark your calendars. This has been put out to ALL DELCO PDs.
- 9. New Duty to Intervene and Act Policy is in place.
- 10. Delaware County Police Reform Task Force set to meet July 10, 2020.

Police Department Activity.

- 1. General Orders related to police operations continue as needed pursuant to operational needs.
- 2. All community activities that involved use of the Borough facilities or meeting in person continues to be on hold. (Citizen's Academy, LOVE Garden).
- 3. Businesses are monitored for compliance with State Orders governing green phase.
- 4. Reports were completed for potential reimbursement expenses related to Emergency Declaration due to violent protests and riots in the area and police responses to ensure public safety and equipment purchases.
- 5. Nextdoor notified me that I was violating their Terms of Service not registered on their site as a LE Officer. The change would drastically reduce my abilities and work conducted in the Community. I have not heard back to change anything, and believe they may have allowed me to continue. I will keep everyone advised as I may take this to the news media if challenged.
- 6. Officers participated in numerous Birthday, Graduation, Anniversary, and party drive-bys during the month at the request of residents or after I offered our involvement. All were well received!
- 7. Officer Murtha resigned and accepted a full-time position with Haverford Police we wish him well. Plans to replace him are on hold for the time being, pending budget review and analysis based on Covid and civil unrest unforeseen expenditures.

Police Training.

- 1. Implicit Bias Training refresher for all officers was completed June 25 and 29, 2020
- 2. Officers continue to utilize PPE and take temp checks 3 times a tour to protect us from COVID.
- 3. Mandatory In-Service Training has resumed as operations have entered the green phase.
- 4. Department is preparing to send at least 2 officers to a Use of Force School in an effort to have in house review of force use, and keep officers up to date in all options.
- 5. De-escalation training is conducted during department daily briefings.
- 6. Social Media is used to keep aware of ongoing issues and as training information.

May God bless us all and keep us well and safe.
