Yeadon Borough now has an official historic tourist attraction at 513 S. Union Avenue!


The Unveiling and Dedication Ceremony for the PA Historical Marker for the Nile Swim Club of Yeadon was held on Sat., May 22, 2021 with hundreds in attendance, including several members of Yeadon Borough Council and other elected officials. All were welcomed by Nile Swim Club President Anthony Patterson and Yeadon Mayor Rohan Hepkins. Other speakers at the event were U. S. Congresswoman Mary Gay Scanlon, PA State Senator Anthony Williams, PA State Representative Margo Davidson, Pennsylvania Historical and Museum Commission Chair Nancy Moses, Yeadon

Borough Historical Commission Vice-Chair William Mellix and family members of Founders Zoe Mask, Carson Puriefoy and Elmer Stewart.

#### The Story Behind The Marker

In 1957, three neighbors (Zoe Mask, Carson Puriefoy and Elmer Stewart), all of whom were third generation out of slavery, went to the Yeadon Borough Hall to submit applications for membership in a newly formed Yeadon Swim Club. They were told they would hear back about their applications. Upon leaving the building, Mr. Puriefoy remembered something that he wanted to add to his

## Yeadon Borough Management Mid-Year Review

NJN & Associates, LLC strives to improve the performance of the Borough by identifying problems and implementing solutions. The recent focus has been related to improving the infrastructure and addressing priority issues within the approved budget. In addition, several grants have been applied for and received to aid in this effort. Below is a list of items accomplished and/or in progress:

- Management applied for the American Rescue Plan Act for emergency grant funds totaling over \$600,000.
- Yeadon Borough was awarded \$200,000.00 from the 2021 Community Development Block Grant for the Sanitary Sewer Rehabilitation of Cypress Street from Longacre Boulevard to Baily Road.
- The National Fitness Campaign awarded the Borough \$30,000 towards the \$185,000 needed for the Fitness Court being installed at the Yeadon Community Park (YCP) later this year. In addition, several donations were received from sponsors totaling \$4,400 and more are expected.
- The Low Volume Road Grant project was completed. Managementand NDI Engineering will be submitting another application for this grant in October 2021.
- Management applied for the 2021
   Healing the Planet Program through
   Keeping Pennsylvania Beautiful and
   The Giant Company for the Fitness
   Court and L.O.V.E. Garden at the YCP.
   Management also assisted the
   Eastern Delaware County Stormwater
   Collaborative in applying for this
   grant for the rain garden being
   planted on Church Lane.
- Management applied for funding from the Greenways, Trails and Recreation Program through the PA Department of Community and Economic Development grant. If awarded, the funds will be used to create a revitalization development plan from the topographic survey performed on Chester Avenue.
- The Eastern Delco Bikeway
   Prioritization study is in progress.

- A COVID-19 call line was setup and run by Management to assist the County and community in scheduling vaccinations.
- Management made technological upgrades to several programs and systems, such as payroll, the phone system, computers, and servers.
- The audit for the 2019 Liquid Fuels Tax Fund resulted in no findings.
- The annual Harassment, Sensitivity, and Customer Service training was held with the employees.
- Management posted and filled several job vacancies.

PECO's Tree Service Contractor
Performing Work This Summer
in Some of Yeadon's Neighborhoods

PECO's Vegetation
Management department has scheduled tree pruning in the Yeadon area to prevent electric service issues caused by broken tree limbs, fallen trees and other vegetation.

This work will begin in July/ August and will be completed in September.

PECO's tree service contractor - specially trained for utility work - will prune to promote tree growth away from power lines and equipment.

Work will take place primarily in the areas south of Darnell Avenue, as shown in the highlighted area of the map at right. Residents affected in these areas will also receive a letter from PECO with additional details.



As always, always look out for one another, and stay safe.



Only use your grill outside. **Keep it at least 3 feet from** siding, deck rails and eaves.




Keep a 3-foot safe zone around your grill. This will keep kids and pets safe.

Nevertheless, trees are vital to shade homes (which reduces the electric bill), save energy, soak up stormwater, clean the air and support birds. As a homeowner, you are able to plant smaller trees on your property, reaping these benefits and helping the environment. So, please consider planting a small tree today.

The Stormwater Collaborative will be installing rain gardens around the borough and holding rain barrel workshops via Zoom (hopefully in person soon). Please be reminded that trash and recycling should be out the night before or by 6 a.m. on collection day. B&L Disposal generally keeps the same scheduling, but on occasion may have to switch their routes and collection times.

Please be sure you follow the ordinance regarding trash and debris as outlined on page 5 under Keeping Up with the Code in this newsletter. The trash should be in a leakproof container, unless it is a trash bag containing leaf and vegetation only.

In addition, the placement of construction materials, such as wood or metal studs, beams, rafters, joists, plywood, sheathing, siding roofing materials, electrical wiring, plumbing materials, cabinets, appliances and other discarded materials of a renovation, repair or construction project shall not be placed out for regular collection. Such items shall be considered bulk pick up and must comply with Subsection I. Please refer to ecode360.com/YE2061 for more information.

#### Code Enforcement Spotlight

## **Keeping Up With the Code**

Here are common code issues that occur during the spring and summer months. Included are the ordinances which can be found online at www.ecode360.com/YE2061. If you have questions or would like to report issues, please contact the Code Department at (610) 284-3110.

#### MISCELLANEOUS PROPERTY MAINTENANCE

Keeping your property in a neat and orderly condition is vital to creating an aesthetically pleasing and safe environment for the community. For example, not displaying a house number can be problematic in the event of an emergency and first responders may find it difficult to locate your home.

Ordinance # 220-16 Exterior Property Areas - Sanitation. All exterior property and premises shall be maintained in a clean, safe and sanitary condition. The occupant shall keep that part of the exterior property which such occupant occupies or controls in a clean and sanitary condition.

#### **HIGH GRASS & WEEDS**

Maintaining your lawn, trees, and shrubs not only makes your property look good, but it will help keep animals and rodents away. It will keep the Code Enforcement Officers away too.

Ordinance # 220-16 Exterior Property Area - D. Lawn and vegetation care - All premises and exterior property shall be maintained free from grass, weeds, or plant growth in excess of 10 inches (254 mm). This shall also include grass, weeds or plant growth located between the curb and sidewalk areas; around poles, post, signs, trees, fire hydrants etc. All noxious weeds shall be prohibited. "Weeds" shall be defined as all grasses, annual plants and vegetation, other than trees or shrubs; provided, however, this term shall not include cultivated flowers and garden.

- D (1) Vegetation along the curb and street line. Vegetation growth along the gutter line adjacent to the curb of a public way shall be prohibited and shall be the responsibility of the property owner.
- D (2) Vegetation overgrowth and obstruction of public ways. Trees, bushes or other vegetation shall not be permitted...
- D (5) Removal of clippings. Clippings from trees, brush, grass, or other vegetation shall not

be left to die or discolor; and shall be swept up, bundled, and removed from the property within seven days. Persons responsible for violation of this section shall be deemed guilty of a summary offense in accordance to § 220-6C and shall receive citations without prior notification as provided for in § 220-7A.

#### **TRASH & DEBRIS**

We can all benefit from taking care of our environment. Seeing trash and debris scattered around the community is unsightly and unsafe. Also, our landfills are overflowing and our oceans and waterways are polluted. We can educate ourselves on better practices to reduce waste, such as composting. There is also an abundance of information out there to help us curb the way we accumulate and dispose of trash and recycling. #### 220-21 Rubbish garbage and recyclable

A. Accumulation of rubbish, garbage, or recyclables. The owner of any premises and or the occupant of any structure, shall be responsible for the exterior property, premises, and the interior of every structure, and shall maintain such areas free from any accumulation of rubbish, garbage or recyclables.

- B. Disposal of rubbish, garbage and recyclables. Every occupant of a structure shall dispose of all rubbish garbage and recyclables in a clean and sanitary manner as prescribed in the Borough's streets, utilities and public services code as outlined in the Code of the Borough of Yeadon, using proper containers as prescribed in this section. Where differences occur between provisions of this code and the standards contained in the Borough's streets, utilities and public services code, the stricter provisions shall apply.
- D. Approved rubbish and garbage containers. An approved rubbish and garbage container (trash can) shall meet the following specification and shall be maintained as follows:
- (1) Must be a leakproof metal or plastic container of not more than 33-gallon capacity which do not, when filled, weigh more than 30 pounds.
- (2) Shall be provided with close-fitting covers or

lids for the storage of such materials until properly disposed of.

- (3) Shall effectively prevent the entry of rain, snow, vermin and vectors therein.
- (4) Shall effectively prevent the escape of noxious odors, effluent, refuse and garbage.
- (5) Shall be maintained in good condition. Any receptacles that do not conform to the provision of this article or that may have ragged or sharp edges or any other defect liable to hamper or injure the person collecting the contents thereof shall be promptly replaced.
- (6) Shall be marked with the address of the property served.
- K. Trash bags. With the exception of approved leaf and vegetation bags, the placement of rubbish and or garbage in plastic or paper bags not concealed in an approved container and or dumpster shall be prohibited.

#### NOTICES FROM THE CODE DEPARTMENT

Please keep in mind that when you receive a violation notice from the Code Enforcement Department you should take care of the issue as soon as possible to avoid further action. If you would like to discuss any issues openly or express your gratitude with the community, you are welcome to attend the Code Enforcement Committee Meetings, which are currently being held at 6:00 p.m. on the second Tuesday of each month via Zoom

#### § 220-7 Violation notices and orders

A. Notice to owner or to person or persons responsible. Whenever the Code Officer determines that there has been a violation of this code or has grounds to believe that a violation has occurred, a violation notice shall be given, in the manner prescribed in Subsections B and C to the person responsible for the violation as specified in this code.

(1) Exception. Violations of some code sections shall not require prior notice, as spelled out in this code, and may result in the issuance of citations in accordance to § 220-6C and D.

application and returned to the office only to find that all of their applications had been trashed. At that moment, he then knew that his children would not be allowed to swim at the white segregated Yeadon Swim Club.

Given this, Mask, Puriefoy and Stewart chose not to ignore the situation or to give money to lawyers to fight it, but rather to build their own swim club to serve Yeadon's African American community. The Yeadon Swim Club's act of segregation gave birth to innovation for this marginalized group. They recruited other families and in February 1958, after much planning and preparation, they formed a non-profit corporation called the Nile Swim Club of Yeadon. The name chosen harkened back to the ancient, lifegiving waters at the heart and soul of their African heritage. In April 1959, the Nile Swim Club of Yeadon made settlement on 2 1/8 acres of land in the Sullivan Tract, which is now known as Yeadon Community Park.

On July 11, 1959, the original founding families stood side by side, surrounded by friends and neighbors, and cut the ribbon on the brand new African American owned and operated Nile Swim Club of Yeadon.

#### Yard Waste Drop-Off

As part of the Department of Environmental Protection Municipal Waste Planning Recycling and Waste Reduction Act (Act 101) the Public Works Department receives yard waste drop off from residents every 2nd Friday of the month from March until October.

Beginning March 12, 2021 through October 8, 2021, every second Friday of the month, residents will be able to bring yard waste to the Public Works Garage for disposal. Yard waste is defined as the following: twigs, sticks, shrubbery, tree trimmings, branches (the tree branches cannot be wider than 4 inches in diameter, and the bundles cannot be longer than 3 feet in length), and similar vegetative material.

#### Twice-a-Week Trash Pick-Up Summer Schedule

Continues until Tuesday August 31st

If your trash is picked up on....

MONDAY: during the summer schedule, it will be collected on **Monday and Thursday.** TUESDAY: during the summer schedule, it will be collected on **Tuesday and Friday.** 

**THURSDAY**: during the summer schedule, it will be collected on **Thursday and Monday**. **FRIDAY**: during the summer schedule, it will be collected on **Friday and Tuesday**.

**RECYCLING PICKUP** occurs throughout the borough on Wednesdays year-round.

\*There is no trash collection on Labor Day, Monday, Sept. 6. It will be collected on Tuesday, Sept. 7.

Grass clippings are not permitted. Leaves will be accepted, but must be separated from all the other materials. The drop off hours will be from 8:00 a.m. to 3:00 p.m. All contractors, landscapers, and tree companies are prohibited from participating. Everyone who comes in must stop at the office first. You will then be shown where to drop off your waste. You will be turned away if what you have is not in compliance with Act 101.

#### **Upcoming Dates**

Upcoming Yard Waste Drop-off events will take place 8 a.m. to 3 p.m. on the second Friday of the month: August 13, September 10, and October 8, 2021.

#### **Bulk Trash Collection**

- To arrange pick up of "white goods," which are large items, such as washing machines, dryers, refrigerators, freezers, and hot water heaters, please call the Public Works Department to schedule a pickup date.
- Collection of any items containing freon will require a \$10 fee which must be paid on the 3rd floor of the Borough Hall before being scheduled to be picked up.
- Sofas, beds, and furniture can be placed out for regular trash, but there is a limit of one large item per trash collection.
- Rugs must be rolled and tied and put out for regular collection.
- Mattresses and box springs MUST be encased in a plastic industrial bag.

#### **Reduce Illicit Discharge**

With the warmer weather and the growing season in full tilt it is important to remember not to blow your grass into the street. Grass clippings in the street often end up in storm drains, and sewers, in addition to being a hazard to motorcycles and cyclists (it also is not very attractive in our neighborhood). Grass clippings, leaves, and other debris tend to clump in storm drains and in sewers. This causes drains to back up, resulting in flooding or drainage issues. As we all know stormwater runoff ends up in our public water ways, carrying hazardous fertilizers and pesticides along with it. Grass clippings also contribute to an abundance of nutrients in our streams that cause unwanted and uncontrolled growth of algae and aquatic weeds that hinders

aquatic life. When cutting your lawn this summer, please remember to blow all grass clippings back in your yard, or bag your clippings and properly dispose of them in your regular trash (make sure they are bagged). Other ways to prevent storm water pollution include but are not limited to the following:

- Properly dispose of hazardous substances such as used oil, cleaning supplies, and paint


   NEVER pour them down any part of the storm sewer system, and report anyone who does!
- 2) Use pesticides, fertilizers, and herbicides properly and efficiently to prevent excess runoff.
- 3) Look for signs of soil and other pollutants, such as debris and chemicals, construction sites left in storm water runoff or tracked into roads by construction vehicles. Report poorly managed construction sites that could impact stormwater runoff to the Borough.
- 4) Install innovative storm water practices on your residential property, such as rain barrels or rain gardens, which capture stormwater and keep it on site instead of letting it drain away into the storm sewer system.
- 5) Report any discharges from storm water outfalls during times of dry weather - a sign that there could be a problem with the storm sewer system.
- 6) Pick up after pets and dispose of their waste properly. No matter where pets make a mess in a back yard or at the park stormwater runoff can carry pet waste from the land to the storm sewer system and then to a stream.
- 7) Store materials that could pollute storm water indoors and use containers for outdoor storage that do not rust or leak to eliminate exposure of materials to stormwater.

Always remember if you see something out of the ordinary to please report the issue right away. During business hours please contact the Code Department (610-284-3110) to report an illicit discharge, after hours please contact the Police Department (9-1-1). Let's work collectively to keep our watersheds and natural habitats safe and clean!

# How to Dispose of Cooking Oil and Grease

Cooking grease and oils will cause problems with your household sewer system. Follow these disposal guidelines to keep your pipes clean!





## **Sanitary Sewer Laterals**

Every property has a sanitary sewer lateral that goes from the house to the main in the street. You may wonder who is responsible for maintenance of the lateral. Property owners are responsible for


ting, or blockage removals, then it is the responsibility of the owner (no matter whether it is in the lawn area or in the street).

Repairs are handed differently. Repairs in the lateral section from the house to the curb are always the responsibility of the property owner. However, if a repair or a replacement is needed in the street section of the lateral, the Borough assumes responsibility.

Please remember to call 9-1-1 for any sewer emergency. A sewer issue is considered an emergency and calling 9-1-1 ensures an expeditious response.

In order to decrease the risk of having a sanitary sewer lateral issue on your property, try avoiding dumping items such as grease down your drain.

### **No Grease in Drains**

Are you aware of the trouble cooking grease causes to your household sewer? When anything goes down a household drain, whether it is in the kitchen, bathroom, or laundry room, the waste has to travel through the house and out to the street in order to continue to the treatment plant.


When cooking grease is poured down the drain, it may start as a free flowing liquid, but when it starts to cool in the pipes or sewers, it begins solidifying. If the household sewage flow is too low, as is often the case in one- or two-person households, the grease may solidify in the homeowner's lateral, or in the Borough's sewer main.


Initially, homeowners may experience a slowing in the draining of sinks, showers, toilets. Ultimately, homeowners may experience a blocked sewer lateral where sewage cannot get out of the lateral, and instead, backs up into the home

Pictures (A) and (B) below are images showing a lateral discharging at the main. As you can see in picture (A), the pipe is clean and unclogged with no visible buildup occurring. While in picture (B), there is a large buildup of grease and debris that is clogging the pipe, preventing the sewage from draining properly from the lateral to the street main.

We encourage all residents/businesses to store grease in a container and dispose of it separately, rather than pouring it down a drain. A backup due to grease buildup is a property owner's responsibility.

Roy is a resident who oversees the recreation programs. He also volunteers and coaches youth sports teams.




**Patricia Criswell Code Department** Office Manager
