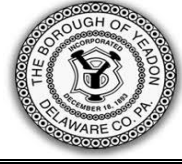




Yeadon Citizen's 2021 Police Academy

Application



Yeadon Police proudly announces its 2nd (restart from Covid) Annual Citizen's Police Academy. The program will run (7) weeks, beginning September 29, 2021 ending with a graduation at a November 2021 Council Meeting. Classes will be held at Yeadon Borough Hall, every Wednesday from 6:30pm to 8:30pm unless otherwise noted in the attached schedule. The academy is free, and class size is limited to 20 residents of Yeadon. Area residents' applications will be considered based on available seating.

The Yeadon Citizen's Police Academy will create a challenging atmosphere, and provide residents/cadets with an inside look at what it takes to be a police officer. This program will create confidence, self-discipline, physical security and fitness awareness, and foster team-building mindsets, while bringing you into the world of policing. Instructors are police officers with a strong desire to open lines of communication with those we swear to protect and serve, to create positive police and public interactions, so that a deeper understanding of policing can serve to foster a stronger bond with citizens and their police officers.

Applicant Requirements:

1. The Academy is open first to all adult residents of Yeadon Borough.
2. Applications from outside interested persons will be accepted on an available seating basis.
3. Applicants must attend each week's session to receive a certificate at the graduation.
4. Yeadon Police reserves the right to deny or remove applicants for past or current behaviors that may be detrimental to the program or other residents/cadets taking part in the program.

Attire:

- Casual attire that is not distracting or offensive.

Safety:

- NO weapons or firearms are permitted during the training, even if you possess a valid Permit to Carry a Firearm.

Graduation:

Upon completion of the academy, there will be an official graduation ceremony at the Yeadon Council Meeting. Family members and relatives are invited to attend.

Application Procedure:

Fill out the application completely. Incomplete applications will not be accepted. Those accepted into the program will be notified by phone/email as soon as possible prior to start of the course.

Waiver/Release of Claims, and Indemnity Agreement

I, _____ am not an employee of the Yeadon Police Department or Yeadon Borough and have made a voluntary application to participate in the 2021 Citizens' Police Academy program scheduled to begin on Wednesday, September 29, 2021 and end on November 11, 2021 (Council Meeting). As part of this program, I understand that the various law enforcement activities I want to participate in may involve some degree of risk of personal injury, and I freely choose to participate in such activities with full knowledge of that risk. I understand that at any time I may choose to not participate in any activity that I feel I may not be able to complete. Furthermore, I agree to the following conditions while participating in the Citizens' Police Academy program:

1. The Borough of Yeadon, Yeadon Police, their administrators, employees, agents or assigns, shall not be held responsible or liable for any injury or damages, loss or expense to either me or my property caused by a Borough of Yeadon Police employee's justifiable act or omission.
2. I agree to follow the exact procedures set forth by the Yeadon Police during this program and shall not hold the Borough of Yeadon, Yeadon Police, their administrators, employees, agents or assigns liable for any injuries or damages resulting from my failure to follow directions or directives.
3. I agree to indemnify, defend and hold harmless the Borough of Yeadon, Yeadon Police, their administrators, employees, agents and/or assigns against any and all claims, demands, damages, actions, causes of actions or suits of any kind or nature whatsoever for any and all injuries and damages, known and unknown, both to person and property, which may result or may in the future develop from my participation in the program.
4. I agree to indemnify, defend and hold harmless the Borough of Yeadon, Yeadon Police, their administrators, employees, agents and/or assigns against any and all claims, demands, damages, actions, causes of actions or suits of any kind or nature whatsoever for any and all injuries and damages, known and unknown, both to person and property, which may result or may in the future develop as a result of any acts or omissions that I may commit.
5. I understand that I am not an employee of the Yeadon Police or Yeadon Borough, and I am not covered by the Yeadon Police or Yeadon Borough's Worker's Compensation insurance.
6. Yeadon Police Department may terminate my participation at any time without notice, and for any reason, but the terms of this agreement shall survive such termination.
7. I will obey and follow all instructions and directions from any Yeadon Police Instructor. I understand that any failure on my behalf to follow the instructions or directives will be grounds for immediate termination of my participation in this program.

PLEASE READ BEFORE SIGNING. By signing this agreement, I declare that I have read this waiver/release of liability, and I fully understand its terms and I understand I have given up certain rights by signing it.
