III. PRESIDENT'S REPORT

President Council-Harris announced that she will be hosting a virtual town hall to address some of the situations that have occurred in the Borough over the past 4 months, along with budgetary matters and updates on the status of current litigation matters.

The virtual town hall meeting will be held tomorrow night, 12/6/22 at 7 pm.

IV. SOLICITOR'S REPORT

Mr. Boggs gave an update on an ordinance that Council will have to pass.

A process passed by the Commonwealth of Pennsylvania for real estate taxes that allows someone to claim that they did not receive notice for their real estate taxes, and they would not have to pay any kind of delinquency. This is a directive for every Borough in Pennsylvania that must be passed and be a part of our code. His only question for Council is where they would like it placed.

VI. MAYOR'S REPORT

Mayor's Forum: The Mayor held a Mayor's Forum on December 1, 2022, in the Borough Hall Auditorium. Approximately 35 people attended. We had prizes and giveaways, and the central theme was updating residents of public safety. The next meeting will be on Thursday, March 2, 2023.

Holding Cell Upgrades: Upgrades in the form of new cameras and monitors along with sound were installed in the police department in November 2022.

Six Recent Tragedies in Yeadon: In addition to the two (2) holding cell suicides, the borough of Yeadon also experienced four (4) executions in a four (4) week period. Two bullet-ridden bodies with shell casings were found in the gateway area on the Yeadon side of Longacre Blvd. and a few weeks later, gunmen opened fire in the parking lot of Restore after a party that had taken place at the Social Space in the 700 block of Church Lane.

Camera footage was provided by the Social Space that helped us apprehend one of the gunmen, while the other 4 gunmen are still at large. A dragnet is out for their arrest. The gunman is from Philadelphia as were the victims.

In light of all these rash incidents, we are certainly experiencing an erosion of public safety and the ability to keep our residents safe.

Public Safety Crisis and Police Staffing Issues: Our current police staffing has hit a crisis. We currently have 16 full-time officers with a perennial need for 21. In addition, two (2) Officers are retiring in January of 2023. We have 2 out on long-term illnesses and 2 are expected to transfer out of the YPD to take jobs in other neighboring boroughs. This would leave us with only ten full-time officers. It would leave us with only one person per shift. That is not enough, as we ideally need 4 or 5 per shift to safely patrol our streets and answer 911 calls.

Civil Service Commission: This needs to be reactivated immediately and full-time officers hired.

Memorandum of Understanding. between Upper Darby PD and YPD: The Mayor has called for a cessation of holding prisoners in our holding cells until three (3) things are finalized within the department, without which, it has proven that we cannot reasonably guarantee safety in our holding cells in light of two (2) recent hangings

D. Public Safety

1. Police Department

- For the month of November, the Yeadon Borough Police Department responded or prepared reports for 639 calls for service.
- There were 102 parking tickets issued.
- There were 4 non-traffic citations issued.
- There were 9 traffic citations issued.
- There were 3 criminal arrests for the month.

Lt Burns wanted to assure the residents that they are safe here in the Borough

E. Recreation

- The rain garden at Guenther and Church Lane has been installed. The garden has trees and shrubs already planted. The plantings are native plants. The project was paid for with a grant of \$19,500 from the Eastern Delaware County Stormwater Coalition. The coalition is looking for additional locations in Yeadon to help with stormwater runoff.
- Mr. Hunter is requesting that Council form a shade tree commission in order to get grants to fund the purchasing of additional shade trees to replace what has been cut down.
- Construction work on Kerr Field is due to start sometime in the spring. A new 8-lane track, football, baseball, and softball fields are projected. For more information, contact the William Penn School District. Mr. Hunter is encouraging residents to be involved in this endeavor.

VIII. CITIZEN'S FORUM

- 1. Colleen Kennedy stated that she is thrilled to hear that the cameras and the sound system have been replaced. She noted there is still no ability to watch meetings from home. There is no active Civil Service Commission. She gave an outline of what community members have gotten accomplished over the last few months and asked that meeting videos be posted online, the rules of the Sunshine Act be followed, that there is a public review of the police department policies, and stop prioritizing one's own political scoring points and start focusing on the issues that the residents have been talking about.
- 2. Diamond Gibbs stated that respect is earned as well as trust and without transparency coming from Council President. She doesn't believe residents will be aware or get answers that are needed for public safety concerns.
- 3. Liz A. believes that nothing Council President has done this year has made any sense. She stated it is not ok for the officers or the residents for 12 officers to be dividing 21 shifts, that is not safe.
- 4. Ms. Anna stated that being as though all of Council are residents of Yeadon public safety should be the highest priority. The police force is understaffed and that is putting residents at risk. We need to convene the Civil Service Commission. She'd also like there to be hybrid meetings.
- 5. Clara Johnson asked that Council President be removed and to bring Chachi back.
- 6. Angela Lee her first concern is public safety. She states she doesn't feel safe here because we don't have adequate police. She feels she's forced to have to get a weapon because we won't hire police and we won't get the Civil Service Commission going. Grants why is everyone around us getting things and we're not. What are the plans for the winter?
