## Police Staffing

With several retirements and transfers to other police departments, the YPD has 13 Full-Time Officers (including Chief of Police). We are currently allotted at 21. We swore in four (4) full-time officers last month (but one of the four left for a more lucrative opportunity leaving us with three). One other could also leave us. Notwithstanding, we currently have a total of 16 full-time officers and one part-time officer (one of the two part-time officers took a full-time position).

I recommend Council authorize the Civil Service Commission to continue to advertise to hire up to five (5) more officers and see where we stand at the end of the process, as it is difficult to get full-time officers who will stay with the department, which has been widely publicized.
