- III. CITIZEN'S FORUM (agenda items only comments limited to 3 minutes)
 - 1. Ms. Liz A. spoke regarding infrastructure and communication issues siting she could not reach anyone at the Borough. * This information is sourced from her sign-in form because the recording began only after she had spoken.
 - 2. Dr. Vivian B. Ford raised a question regarding the selection process for new Councilors, noting the apparent use of two different procedures: direct selection and interviews. She inquired about the reasoning behind this approach. She also mentioned her difficulty in hearing and suggested that the borough consider providing technology to assist individuals in similar situations.
 - 3. Ms. Anna discussed the importance of fiscal management, particularly focusing on monitoring engineering expenses to ensure they align with expectations. She also requested more information regarding an ordinance on concealed face coverings and emphasized the need for transparency and fiscal responsibility in appointing a new Councilor.

V. MAYOR'S REPORT

Mayor Hepkins asked that his report stand as submitted during last week's Caucus meeting. He highlighted the upcoming Mayor's Forum scheduled for Thursday, March 7th, where Dr. Becoats will attend and address questions regarding the field and the school district for residents.

President Monroe mentioned Speaker McClinton's advocacy for the newly increased child tax credit, which will now be matched by the state at 100%, providing up to \$2100 back to families. This initiative aims to alleviate financial burdens on working families. Speaker McClinton operates quietly and effectively within our Borough. Just recently, we received news about a grant awarded to our Police Department. We are truly grateful for these developments and hope for more positive news in the future.

Mr. Nichols reminded residents to file their local taxes with Keystone Collection Group when submitting federal and state taxes. Failure to do so may result in notices and late fees. He requested his report be accepted as submitted at Caucus.

VIII. SOLICITOR'S REPORT

Mr. Kilkenny reported due to the questions at the committee meeting. He provided a follow-up in an executive session regarding property maintenance code issues. He assured vigorous pursuit of these matters with collaboration between offices, expecting progress soon. He concluded his report unless there were further questions on the mentioned properties. Additionally, he announced an Executive session was held at 6:30 PM to address personnel and litigation matters.

IX. TAX COLLECTOR'S REPORT

Ms. Hughes requested that her report stand as submitted at last week's meeting. She noted she has collected more money but mentioned ongoing issues with the calculation and record-keeping program. She assured a comprehensive report would be available at the next meeting. Regarding online payments, she advised waiting a couple of weeks due to glitches in the system to ensure accurate records. If already paid online, individuals were instructed to contact her office and stated that further communication would follow through a letter.
