V. MAYOR'S REPORT

Mayor Hepkins reported the following:

My report stands as submitted last week at Caucus. Councilor Jesse Peets and I have finalized the 2025 schedule for public safety meetings and the quarterly Mayor's Citizens Forum. The schedule has been submitted and will be available online soon.

I'd also like to note that the public safety meeting scheduled for Saturday has been canceled, as year-end gatherings often see lower attendance. This marks the conclusion of a successful year with 11 meetings and a December Mayor's Forum.

VI. ENGINEER'S REPORT

1. Motion to open a hearing for the CDBG Application for sanitary sewer replacement on Bullock Ave between Darnell and Parmley.

Megan from Pennoni Engineering provided the following summary during the public hearing for the Delaware County CDBG application:

The hearing concerns the replacement of approximately 600 linear feet of sanitary sewer on Bullock Avenue, including 50 laterals. While the project is significant, initial estimates—developed in collaboration with Public Works—suggest it will cost around \$500,000. This figure will serve as the grant request amount. However, the team is also exploring more cost-effective alternatives, if feasible, to ensure the best use of resources. Megan emphasized the importance of requesting a grant that reflects the potential full project cost to avoid underfunding. She concluded by inviting any questions from Council.

President Monroe sought clarification, asking, "So, the blue represents the main sewer line?" The response was affirmative, with an explanation that the green lines represent laterals—one per household. It was further clarified that for twin structures, there are two laterals per structure, as each individual dwelling has its own line.

Bryant also highlighted that the firm had recently drafted the Lead Inspection Ordinance and a resolution to ratify the Civil Service Commission's bylaws, emphasizing these as part of their ongoing efforts for the upcoming year.
